Two Trips to Wales on the Horizon



Last month, KTA announced a fundraiser trip along the **Wales Coast Path** between the towns of Aberystwyth and Newport.

We now have definitive dates to share, and thanks to overwhelming interest, we will hold a second trip! KTA heads to Wales on **Aug 15-26th** and again **Sep 26- Oct 7th.**

The route includes a total of 68 miles spread over seven days of hiking with a rest day in between. It is clifftop hiking at its finest, along Cardigan Bay and the Irish Sea on the country's southwest coast. Enjoy secluded coves, picturesque fishing villages, and quaint towns making your way to guesthouses and small hotels for evening lodging. Luggage is forwarded so participants need only carry a daypack.

This trip will be limited to 12 participants plus two leaders. Registration opens on December 15th.

Wonderful Wildwood Workday

<u>Wildwood Park</u> is a Dauphin County gem, located less than a mile north of Harrisburg Area Community College. The park's East Shore Trail borders expansive wetlands and mature woodlands on its gentle route.

As part of the park's monthly volunteer day, KTA organized trail maintenance tasks along the East Shore Trail, including the installation of rock culverts for improved drainage and excavating sediments and organic debris that accumulated along the upslope of raised boardwalks (thus, impeding proper drainage).

A crew of ten made the work easy, fun, and fast. As is often the case with trail maintenance, there's more work to be done, but passers by and park personnel noted the difference — and complimented the effort. A big thanks to all that helped, and a special shout-out to KTA Board Member, Karen Lutz, for sharing her extensive trail tending expertise.

DCNR Announces New Reservation System for SF Campsites

Camping reservations in state forests are currently made by visiting a state forest district office and requesting a permit from district forest staff.

The new system will allow visitors to also make reservations<u>online</u>, by phone (888-PA-PARKS), or <u>in app</u>. This move to modernize will let visitors view real-time availability date and allow DCNR to access better campsite use data.

The number of camping permits issued has doubled in the past five years, creating a need for electronic records and reporting to help district forest staff effectively manage campsite conditions, perform necessary maintenance, and provide site alerts about site specific conditions that may arise, including road closures, flooding and other emergencies. The new system introduces a number of changes to **state forest camping policies**.

There will be nightly fees of \$10 for Pennsylvania residents and \$15 for non-residents, with a \$6.50 transaction fee to cover costs of operating the systems. The new system will allow use of credit cards for camping and other permits, such as fuelwood and ATVs.

There will continue to be no fee for trailside, backpack camping, and water trail camping.

Fees may be waived for volunteers during work projects.

According to DCNR, revenue generated from the fees will be directed towards maintenance, improvement, and conservation of sites and associated recreation opportunities.

DCNR Seeks Public Comment On Catawissa Recreation Area Master Plan

DCNR is seeking public comment on the master plan to create the Catawissa Recreation Area in both Schuylkill and Luzerne counties. DCNR Secretary Cindy Adams Dunn and State Forester Ellen Shultzabarger, are asking the public to weigh in on the plan which gives off-road enthusiasts a public place to drive.

Tentatively set to open in the summer of 2023, the Catawissa Recreation Area is a 5,541-acre parcel of land that will be developed into a motorized recreation area in the Weiser State Forest in Schuylkill and Luzerne counties. DCNR is working with the Larson Design Group and The Markosky Engineering Group to develop the master plan for the recreation area.

KTA has voiced concern over the ATV Connector Pilot in northcentral Pennsylvania, noting that the resource degradation caused by ATVs and UTVs is incongruent with sustainable management values of the state forest system. The Catawissa Recreation Area is being developed on land that was previously a privately-operated park for ATVs and other users. This prior use makes it a preferable site for ATV activity. Nevertheless, it is part of the state forest estate, magnifying the conundrum of this kind of recreation on state forest land, and bringing new management burdens to the Weiser State Forest staff.
