Joanne has participated in KTA trail care weekends and has attended spring and fall KTA hiking weekends. She believes in KTA's mission and wants to see KTA prosper.

Call for Nominations KTA Board



Funding for Trails American Rescue Act

We currently have a historic opportunity to use county and municipal ARPA funding to support parks, trails, recreation, and conservation in every community across PA. The details of that opportunity are outlined in the video and memo below:

Although many municipalities and counties are currently discussing allocations to conservation projects, some municipal advisors had expressed doubt that this was an appropriate use of funds. Fortunately, the US Treasury recently provided an <u>updated set of FAQs</u> to provide further guidance on eligible uses for ARPA funds. The updated FAQs (as of July 19, 2021) make it very clear that investing in parks, open space, recreation, trails, and conservation are eligible uses for ARPA funds and that counties and municipalities have significant discretion in how to award funds to such projects. I have attached an excerpt of the relevant portion of the FAQs, which could be shared with stakeholders—including those who may be skeptical—when making the case of the use of funding.

Allegheny Front Trail Care Report

The volunteer crew of dedicated trail maintainers put in 100 hours of work on the Allegheny Front Trail despite the dodgy weather conditions that prevailed during the weekend. Our experienced sawyer team removed all blowdowns, of which there were a significant number, from where the trail crosses Meyers Road south to where it crosses Underwood Road, which covers about 1/3 of the 41 mile loop on its eastern side. We also brush cut and opened the trail corridor from Underwood Road, going north, to the south fork of the headwaters of Whetstone Run which entailed cutting back laurel that was overgrowing the trail, never an easy do. This is part the section that goes along the front itself with a series of views and vistas into valley far below. I would like to thank the participants who took the time to come work on the trail. They were: Wanda Shirk, Tom Bastian, Elwood Loudenslager, Tony Robbins, John Eveler and Ed Lawrence.

Long Mountain Trail Cleared

A massive thank you to the team of volunteers that came out to our last Conservation Volunteer Day, June 26th, on Long Mountain Trail. Sixteen volunteers and three DCNR staff worked throughout the day to cut back brush, remove debris, and cut downed trees to clear the trail corridor. Long Mountain, connecting Penn Roosevelt State Park to Alan Seeger Natural Area, is currently in the best shape it has been for several years and is ready for all trail users to enjoy.

Musser Gap Progress

While the trail design work we discussed in our last update will soon resume, there is currently some great trail construction underway in Musser Gap. DCNR is on the ground building a new 2,600-foot trail connecting the main access trail to Mountain Mist Trail. Led by Eric Berendsen, an experienced, professional trail builder and a recent addition to the DCNR staff, along with a number of volunteers, progress has been exceptional. Eric has previously worked with Dirt Artisans on local projects such as Colyer Lake, Harvest Fields Community Trails, and nearby Jake's Rocks.

Work is expected to continue, as conditions permit, with a hopeful trail opening later this fall. Until the trail is completed, we ask that everyone stay clear for the sake of safety.

Hiker's Corner

Twin Lakes Trail Allegheny National Forest



<u>Jeff's Jaunts</u> <u>Golden Eagle Trail - Tiadaghton State Forest</u>

I met some friends from college to hike this excellent loop, totaling 10.3 miles. It follows the classic Golden Eagle Trail and the fairly new Dragon's Back Trail featuring several views, rock outcrops, and cascades. It is considered one of the finest dayhikes in the state. I recommend adding the Dragon's Back



Trail as I feel it is more scenic than the Golden Eagle Trail along Bonnell Run, which is still very scenic with a gorge of open hardwood forests.

From the parking area, we crossed PA 414 and began on the GET as it climbed up a gorge. We turned right to begin the loop as falls tumbled below us to the left. We made the long climb up to the ridge, which steepened as we neared the top. It was getting warm and the sunlight filtered through the forest. We reached the ridge and enjoyed the breeze as we descended passing a fine view to the left that

looked up Wolf Run and then shortly thereafter, the classic view from Raven's Horn and its unique rock outcrop. The view was stunning as we looked into the Pine Creek Gorge as green mountains surrounded us.

Our descent continued along the ridge, passing more unique rock outcrops. The trail then followed Wolf Run, which was flowing low, but has many cascades and small falls in a deep gorge. We passed outcrops of flagstone, with sheaths of rock that looked stacked. The trail along the creek was beautiful, and we crossed it several times. When flowing well, Wolf Run is truly beautiful. As we neared the top, there was a an old growth forest of giant pine and hemlock. We reached our first view and then hiked through the laurel to an old forest road, which we took to



Beulahland Vista, a gorgeous view looking over the fields and mountains of northern Pennsylvania.

We continued on the grassy road, passing another excellent view, Bonnell Run Vista. The GET then turned left, but we continued straight on the grassy forest road to hike the Dragon's Back Trail. We soon entered the woods and followed the yellow blazes along the forested ridgeline that narrowed with steep slopes on both sides. We enjoyed another view, Webber's Vista, looking down on Slate Run. We made another short climb, and then descended on a series of grades that switchbacked down to PA 414.

We crossed the road, walked down to the rail trail, and turned left on it. The rail trail had great views of Pine Creek, wildflowers, and even an old cemetery. It was a great way to end the hike. We reached our cars and went to Slate Run for a meal.

Pine Creek Gorge has dozens of excellent hiking trails for any ability. However, hiking here generally means climbing. The views make it more than worth it.
